**STIPULATION** 

a Justice of the Petersburgh Town Court, Rensselaer County.

IT IS HEREBY STIPULATED AND AGREED by and between Robert H.

Tembeckjian, Administrator and Counsel to the Commission on Judicial Conduct,
and the Honorable Richard T. Snyder ("Respondent"):

- Respondent has been a Justice of the Petersburgh Town Court,
   Rensselaer County, since January 2014. His current term expires December 31,
   Respondent is not an attorney.
- 2. Respondent was served with a Formal Written Complaint dated November 12, 2024, which is appended as Exhibit A.
- 3. Respondent enters into this Stipulation in lieu of filing an Answer to the Formal Written Complaint.
- 4. Respondent has tendered his letter of resignation, a copy of which is annexed as Exhibit B, stating that he will vacate judicial office on December 31, 2024.

- 5. Pursuant to Section 47 of the Judiciary Law, the Commission may continue with proceedings against a judge who has resigned and, if it so determines, render and file a determination that the judge should be removed from office. Pursuant to Article VI, section 22(h) of the Constitution, a judge who is removed from office "shall be ineligible to hold other judicial office."
- 6. Respondent affirms that he will vacate his judicial office at the close of business on December 31, 2024, and he will neither seek nor accept judicial office at any time in the future.
- 7. Respondent understands that, should he abrogate the terms of this Stipulation and hold any judicial position at any time in the future, the present proceedings before the Commission will be revived and the matter may proceed to a hearing before a referee, or the Commission may summarily determine that he should be removed from office pursuant to 22 NYCRR 7000.6(c).
- 8. Upon execution of this Stipulation by the signatories below, this Stipulation will be presented to the Commission with the joint recommendation that the matter be concluded, by the terms of this Stipulation, without further proceedings.
- 9. Respondent waives confidentiality as provided by Section 45 of the Judiciary Law, to the extent that (A) this Stipulation will become public upon

being signed by the signatories below, and (B) the Commission's Decision and Order regarding this Stipulation will become public.

# FORMAL WRITTEN COMPLAINT

a Justice of the Petersburgh Town Court, Rensselaer County.

- 1. Article VI, Section 22, of the Constitution of the State of New York establishes a Commission on Judicial Conduct ("Commission"), and Section 44, subdivision 4, of the Judiciary Law empowers the Commission to direct that a Formal Written Complaint be drawn and served upon a judge.
- 2. The Commission has directed that a Formal Written Complaint be drawn and served upon Richard T. Snyder ("Respondent"), a Justice of the Petersburgh Town Court, Rensselaer County.
- 3. The factual allegations set forth in Charge I state acts of judicial misconduct by Respondent in violation of the Rules of the Chief Administrator of the Courts Governing Judicial Conduct ("Rules").
- Respondent has been a Justice of the Petersburgh Town Court,
   Rensselaer County, since January 2014. His current term expires December 31,
   Respondent is not an attorney.

# **CHARGE I**

- 5. On or about October 18, 2023, and on July 16, 2024, Respondent made statements that undermined the independence, integrity and impartiality of the judiciary, and otherwise demonstrated his unfitness for judicial office, in that:
  - (A) on or about October 18, 2023, in an effort to be excused from Grand Jury duty, Respondent (i) asserted his judicial office when he introduced himself as a town judge to the presiding justice, and (ii) advised the presiding justice that he could not serve as a Grand Juror because he believes anyone who comes before him is guilty and therefore he could not be impartial; and
  - (B) on July 16, 2024, while appearing for testimony at the Commission's Albany office, Respondent demonstrated bias by repeatedly stating his belief that all litigants who appear before him "did something wrong," even if they are presumed innocent until they "come to court."

# **Specifications to Charge I**

- 6. On or about October 18, 2023, having been summoned for jury duty, Respondent appeared at the Rensselaer County Courthouse in Troy, New York.
- 7. On that same date, Supreme Court Justice Laura M. Jordan presided over a Special Grand Jury Empanelment at the Rensselaer County Courthouse, at

which Respondent was present. Assistant Attorney General Andrew M. McElwee was also present.

- 8. After the prospective Grand Jurors including Respondent were sworn, Justice Jordan announced that those who felt unable to serve could approach the bench and speak with her on the record, to explain their circumstances.
- 9. Respondent, who was identified as "Juror 15" in the pool of prospective Grand Jurors, requested and was granted permission to approach the bench, where he advised Justice Jordan on the transcribed record, "I'm the Town Judge in Petersburg[h]," and "I don't think I should be on this jury." A copy of the transcript is appended as <a href="Exhibit 1">Exhibit 1</a>.
- 10. When advised by Justice Jordan that judges are not exempt from jury duty, Respondent replied, "I know," and stated, "I have Court on a lot of those same nights." Justice Jordan told Respondent that the Assistant Attorney General would conclude the Grand Jury proceedings by 4:30 PM each day. In response, Respondent asserted, "I have to get set up by 5:00 and I live in Petersburg[h]." 1
- 11. Respondent then volunteered, "I know everybody come in front of me, I know they are guilty. They would not be in front of me."

- 12. Justice Jordan asked Assistant Attorney General McElwee if proceedings would go until 4:30 PM on "most days," to which he responded by addressing Respondent and stating, "No. If you have a particular night you need to leave early, I can let you out early." Justice Jordan then requested that Respondent take his seat.
- 13. Upon returning to his seat, Respondent raised his hand signaling he wished to speak with Justice Jordan again. When called upon, Respondent approached the bench and said, "I just think I cannot do it, because [sic] being a Judge and everything." Justice Jordan asked Respondent, "You don't think you can be impartial?" Respondent replied, "No. It would not be fair."
- 14. Justice Jordan thereafter excused Respondent from serving as a grand juror, to which he stated, "Okay. Sorry about that."
- 15. On July 16, 2024, Respondent appeared at the Commission's Albany office to testify in connection with an investigation into the statements he made during Grand Jury selection. A transcript of his testimony is appended as <u>Exhibit</u> 2.
- 16. When asked to explain his statements as a prospective Grand Juror and specifically his statement, "I know everybody come in front of me. I know they are guilty. They would not be in front of me." Respondent testified under oath as follows:

- A. "I meant that, reason why people got tickets is because they did something wrong. But I know people's [sic] not guilty. They're innocent until proven guilty" (Exhibit 2 at 22);
- B. "Well, like speeding, or maybe they broke into somebody's house or committed a crime. That's the reason why they got a ticket to appear in court because they did something wrong. But like I said, I know they're not guilty. They're innocent till proven guilty, but . . ." (*id.*);
- C. "Or they violated an order of protection or something like that. They did something wrong" (*id.* at 23);
- D. [When asked if a defendant appearing before him on a misdemeanor charge had done something wrong:] "Probably, but not they've got to have proof that they did it, you know" (*id.*);
- E. "I know they're guilty because they did something wrong. That's how they got a ticket" (*id.* at 24);
- F. "I meant, that they were guilty because they did something wrong. But they're not guilty till they come to court. They're innocent till proven guilty" (*id.* at 25); and
- G. "They did something wrong. That's why they got a ticket. But they're not guilty" (*id.* at 33).
- 17. By reason of the foregoing, Respondent should be disciplined for cause, pursuant to Article VI, Section 22, subdivision (a), of the Constitution and Section 44, subdivision 1, of the Judiciary Law, in that Respondent failed to uphold the integrity and independence of the judiciary by failing to maintain high standards of conduct so that the integrity and independence of the judiciary would be preserved, in violation of Section 100.1 of the Rules; failed to avoid impropriety and the appearance of impropriety, in that he failed to respect and comply with the law and failed to act in a manner that promotes public confidence

in the integrity and impartiality of the judiciary, in violation of Section 100.2(A) of the Rules, and lent the prestige of judicial office to advance his own private interest, in violation of Section 100.2(C) of the Rules; failed to perform the duties of judicial office impartially and diligently, in that he failed to perform judicial duties without bias or prejudice against or in favor of any person, in violation of Section 100.3(B)(4) of the Rules; and failed to so conduct his extra-judicial activities as to minimize the risk of conflict with judicial obligations, in that he failed to conduct his extra-judicial activities so that they do not cast reasonable doubt on his capacity to act impartially as a judge, detract from the dignity of judicial office, or interfere with the proper performance of judicial duties, and are not incompatible with judicial office, in violation of Sections 100.4(A)(1), (2) and (3) of the Rules.

WHEREFORE, by reason of the foregoing, the Commission should take whatever further action it deems appropriate in accordance with its powers under the Constitution and the Judiciary Law of the State of New York.

7	A. Yep, yep. I passed every test I took.
8	Q. Do you have any employment or jobs outside your judicial role?
9	A. Yes. I'm a caregiver to my grandkids. I watch him every day. I've done
10	that since he was a year old. He's nine now. And I get him on the bus in
11	the morning, take care of him, get him off the bus at night, and I watch
12	him till the parents get home because both of them work out of town.
13	Q. How many grandchildren do you have?
14	A. I have six altogether.
15	Q. And you care for how many of them?
16	A. I care for one right now. And I have another one next year starting
17	school. I'll be putting him on the bus, too, and getting him off and
18	watching him.
19	Q. And you consider this to be employment or something that you do for
20	family responsibility?
21	A. For family because it's a hardship to my parent my daughter and her
22	and I
23	Q. What's your prior employment history?
24	A. I was a QA Tech, and I was a boss for 20 years for
25	O. What's a OA Tech, please?

- 1 A. Check parts out, make sure they're all right. 2 Q. What kind of parts? 3 A. Carbon fiber tables. You know, the tables -- you're x-rayed, and you lay down when you get x-rayed? I did that for 34 years. 4 5 Q. Who was your employer? A. Vermont Composites. 6 7 Q. Can you spell that, please? 8 A. Vermont --9 Q. Oh, Vermont. 10 A. Yeah. 11 Q. Vermont Composites. 12 A. Sorry about that. I'm getting hoarse. 13 Q. That's okay. And where was that located? 14 A. Bennington, Vermont. Q. Any other employment? 15 16 A. I worked in a sawmill for eight years in Berlin, W. J. Cowee's (phonetic). 17 And before that, I worked in a grocery store helping out. 18 Q. Did you retire from --
- 19 A. Vermont Composites, yeah, yeah.
- Q. And I appreciate your being helpful by answering the questions, but if you would just be so kind to let me finish my question before you --
- 22 | A. Yeah.
- 23 | Q. -- answer --
- 24 | A. Yeah.
- 25 | Q. -- because the record has difficulty picking up when we talk over each



1	other
2	A. Yeah.
3	Q okay? I'm sorry. So what year did you retire from Vermont
4	Composites?
5	A. You're going to have to I'd be eight years November, so and the
6	reason why I retired is to watch my grandson so my daughter could go
7	back to work.
8	Q. What year did you become a Judge?
9	A. 2014. I'm in my 11th year now.
10	Q. And you were are you elected or appointed?
11	A. Elected.
12	Q. Is your judicial position full- or part-time?
13	A. Part-time.
14	Q. Do you have a co-Judge?
15	A. Yes.
16	Q. Who is that?
17	A. Amy Manchester.
18	Q. Do you have support staff?
19	A. I got a Court Clerk.
20	Q. Who is that?
21	A. Allison Oswald.
22	Q. What is your court schedule?
23	A. Second Tuesday and the fourth Tuesday of each month. And we're there
24	every Tuesday. And I'm there about every day, going in, checking
25	messages and emails, and getting mail.
ı	

A. Yes.

Q. Okay. When I ask you this question --1 2 A. Yeah. 3 Q. -- when do you sit? You're saying "we". When do you sit --A. I sit --4 5 Q. -- on the bench? A. -- just about every -- second and the fourth Tuesday, I sit just about every 6 7 month. 8 Q. What do you mean by "just about"? 9 A. Well, sometimes I don't have a case, but I'm there. 10 Q. Why are you there when you don't have a case? 11 A. Well, we just -- we're there, you know, to help out, support, or whatever, 12 you know. 13 Q. When you say "we're there", who are you talking about? 14 A. My other co-Judge and my Court Clerk. It's --Q. Do you have --15 16 A. -- vice versa --17 Q. Do you have specific calendar nights assigned to you? 18 A. Yes. 19 Q. What are those --20 A. It's --Q. -- where you're required to be --21 22 A. Every other month. So I'm on -- like, she was on this month, and I'm on 23 September. 24 Q. And when you say "she", you mean Judge Manchester --

Q. -- was on for the month of July? 1 2 A. Let's see, July -- no, I'm on July, and then she's on August, and I'm on 3 September. We rotate every other month. But sometimes I have cases that get adjourned to -- if, like, the ADA comes in or a Public Defender, 4 5 he wants to push them out to the next month, so I'm on again that month, 6 too. 7 Q. But you're scheduled to be there two nights --8 A. Yeah. 9 Q. -- and that's the second and fourth Tuesday of the month, every other 10 month; is that correct? 11 A. Yes. 12 Q. What time does court begin? 13 A. First night is six o'clock, and the next night is 7:00. The fourth Tuesday 14 is 7:00. O. All right. And when you say "the first night", you mean the second 15 Tuesday of the month --16 17 A. Yeah. 18 Q. -- begins at 6:00 p.m.? A. 6:00. 19 20 Q. All right. You have to let me finish, Judge --21 A. Yeah. 22 Q. -- all right? 23 A. Yeah. 24 Q. So the first Tuesday, the court begins at 6:00? 25 A. Yes.

1	Q. The fourth Tuesday, court begins at 7:00?
2	A. 7:00, yes.
3	Q. All right. We'll discuss a little bit more about the Court's schedule later
4	on, but what is your judicial salary, Judge?
5	A. 6,000 something a year. I bring home 400 a little over 400 each month
6	I get paid monthly.
7	Q. When does your current judicial term expire?
8	A. Next year.
9	Q. The end of 2025?
10	A. Yeah.
11	Q. All right. Switching gears, Judge, now I'm going to ask you some
12	questions about what brought you here today. Did you appear on
13	October 18, 2023, in Rensselaer County Supreme Court for grand jury
14	empanelment?
15	A. Yes.
16	Q. And were you administered an oath on that day and sworn in as a
17	prospective grand juror?
18	A. I don't remember getting sworn in, tell you the truth. But I was so, you
19	know, I went up to the bench, and she asked me why should I not be on
20	the because I said, "I don't think I should be on the court because I'm
21	Town Judge". And first thing she said, "Well, gratulations [sic]", you
22	know, like, that to me, you know. Got me so upset. I was so nervous,
23	you know?
24	Q. Why would you be upset that the Judge congratulated
25	A. I don't know.

Q. -- remember --

1 Q. -- you? 2 A. Just like, she had a thing out for me or some way, way she acted, you 3 know? O. That she had what out for you? 4 5 A. She had something out for me. I don't know. Q. Are we talking about Supreme Court Justice Laura Jordan? 6 7 A. I think, yeah. I think that's what her name was. 8 BY MS. KLEIN: 9 O. Judge, you indicated you had an opportunity to review the letter from the 10 Deputy Administrator. Did you review the complaint filed with this 11 office by Supreme Court Justice Laura Jordan? 12 A. Yes. That was a while back when I first got it. 13 Q. Judge, do you have any recollection of a mass swearing-in where you had 14 to raise your hand? 15 A. I don't remember being -- I don't remember. 16 Q. Do you note that Judge Laura Jordan indicates that you stated under oath 17 and that you were under oath in her --18 A. Yeah. 19 Q. -- complaint? 20 A. But I don't remember getting sworn in, tell you the truth. 21 Q. Do you dispute that, then? 22 A. Kind of. I don't remember. 23 Q. But Judge, if you're telling me you don't --24 A. Yeah.

1 A. Yeah. Q. -- is it possible that it happened? 2 3 A. It's possible, yes, but. Q. Did you also have an opportunity to review the transcript that was 4 5 prepared --A. Yes, I read it. Yes. 6 7 Q. You have to let me finish --8 A. Yep. 9 O. -- Judge. 10 A. Oh, sorry. 11 Q. Thank you -- the transcript that was prepared in connection with the 12 October 18, 2023, grand jury empanelment; you had that --13 A. Yeah. 14 Q. -- opportunity? A. Yes, I read it over. 15 16 Q. All right. Do you see on page two of five of the transcript where it says, 17 "The grand jury was then duly sworn and responded with a collective" --18 A. Yeah. Q. -- "yes"? 19 20 A. Yeah. Yeah. Q. Does that help with your recollection at all? 21 22 A. Yeah, it could be, yes. I was kind of so nervous that day, you know? 23 Q. Why were you nervous? 24 A. I don't know. I don't know. I'm nervous right here today coming up here.

I'm a nervous person. You know?

1 Q. You were nervous because you were appearing in front of a Judge? 2 A. You know, I just got nervous the way she acted to me. 3 Q. All right. So you don't remember being sworn in? 4 A. No, no, I don't. 5 Q. Were you the individual identified in the transcript as Juror 15? A. Yes. 6 7 Q. So you remember that? 8 A. Yes. Well, can I say something? 9 Q. In a moment, please. When your name was called, they said the -- it says 10 on page two --11 A. Um-hum. 12 Q. -- line nine, "Richard Snyder." Grand Juror response --13 A. Yeah. 14 Q. -- ten, line ten, "I'm the Town Judge in Petersburgh". Is that what -- was 15 that your response that day? 16 A. Yes, I thought I was -- I didn't think it would be -- that I should be on a 17 jury being the Town Judge. That's what I told her. 18 Q. And why is that? A. I don't know. Just that a lot of people say -- you know, I talked to them. 19 20 They said, "No, they're not going to pick you. You're a Town Judge" and 21 stuff like that. "They don't want a Town Judge on the jury", you know, 22 SO --23 I talked to my -- Dave Dellehunt. I don't know if you know him. He was 24 a -- he was my boss at the Court. And he told me that I should have -- I 25 should have said that I was caregiver to my grandkids, you know, instead

1	of saying that, but
2	Q. When did you talk to Dave Dellehunt?
3	A. After I got this. I called him and asked him some questions about it.
4	Q. After you got the what?
5	A. This. The first thing. Now, he's retired.
6	Q. What's your relationship with Mr. Dellehunt?
7	A. He's kind of our Counsel for our court. We have any questions, we call
8	him.
9	Q. So why did you why was the first thing that you said was "I'm the
10	Town Judge in Petersburgh"?
11	A. Well, I just figured that she would excuse me. Then, when I said that,
12	she told me she said, "Well, we're probably not going to pick you
13	anyways, but" she says, "Sit down. Go take a seat". And so I went out
14	and sat down.
15	Q. I'm going to ask you to show me in this transcript where Judge Laura
16	Jordan told you she probably wasn't going to pick you anyway.
17	A. Well, I didn't see that in there anywhere, but that's what she told me.
18	Because I looked at that and that wasn't in there, but that's what she told
19	me.
20	Q. Are you saying that this transcript's not accurate?
21	A. I would say it's accurate, but that's what she told me.
22	Q. Who was present when she told you that?
23	A. There was two girls standing there they were right in front of me and
24	some guy on the side of me. I don't know who he was. There was two
25	people that worked for the Rensselaer County Court were there with

1	clipboards.
2	Q. Okay. Did you see anything inappropriate about identifying yourself as a
3	Judge as soon as you stood up in grand jury?
4	A. No. One thing I noticed was when she told people get in line if they don't
5	want to be don't think they should be can't do this court, I noticed a
6	lot of women went up, and she excused them for some reason.
7	Q. Why were you trying to be excused?
8	A. Because I didn't want because it's hardship to me. Like, my daughter
9	told me, you know, "This is hardship for us if you're going to be on this
10	jury". It was for six weeks, and we I don't have she don't have
11	anybody to watch the kids, you know? Like I said, I've watched the kid
12	since he was a year old he's nine now every day. I ain't had a
13	vacation in 15 years.
14	Q. What was your understanding of the duration of grand jury?
15	A. They told me it was going to be for six weeks.
16	Q. How many days a week?
17	A. Every day as far as I know. That's what he said. Except Fridays, maybe.
18	Q. From what time to what time?
19	A. He didn't really give me a time.
20	Q. Did you ask to be excused from grand jury service because you have a lot
21	of court on those same nights?
22	A. Yes. And it's, you know, like, 30 minutes to Petersburgh. And then I got
23	to go home, get my you know, get dressed up, take my medicine I take,
24	eat my supper, go up let my daughter's dog out.
25	Q. Could you have coordinated with your co-Judge to take the bench on

1	nights that you were held in grand jury?
2	A. We don't usually do that because we each have our own cases, you know.
3	I've only done it once because she was on a her nephew got in an
4	accident, and I took her cases that night. That's the only time we ever
5	done it.
6	Q. How long does it take to get from Troy to Petersburgh Town Court?
7	A. It's roughly 30 minutes.
8	Q. Do you recall the Court saying to you that it's probably going to go to
9	4:30 most days?
10	A. Um-hum. That'd be cutting it pretty close because I get there around
11	4:30.
12	Q. Get where around 4:30?
13	A. At court. We don't have a Court Officer. We get there, open up, unlock
14	the place, get everything set up, get the recorders set up, get the room set
15	up for the people to come in, and when the people come in, we meet with
16	them, tell them where to go, sign in.
17	Q. Court doesn't start till 7:00 or 6:00, though, correct?
18	A. 6:00, yes, but we get there around 4:30 or 5:00, roughly around that time.
19	Q. You keep saying "we". Who are you talking about?
20	A. My Court Clerk and my co-Judge. We all get there around the same
21	time.
22	Q. If they're there, why do you need to be there?
23	A. Because we all got to get there, sign in I mean, get people signed in and
24	everything for court.
25	O Did you testify that you're at the courthouse every day?

- 1 A. Just about every day doing paperwork.
- 2 | Q. From when to when are you there every day?
- 3 A. It varies, you know. I get there usually around 10:00.
- 4 | Q. Whose requirement is that?
- 5 A. Nobody's, but we just do that. I've been doing it since I've been a Judge.
- Q. At this point, I'm going to go through this transcript since you've told me that you --
- 8 A. Yeah.
- 9 Q. -- believe it's missing things, and I want to know what's accurate --
- 10 | A. Yeah.
- Q. -- from this transcript, okay, in your view. Starting from page two, line nine, "The Court calls Richard Snyder". Grand Juror, "I'm the Town Judge in Petersburgh." That's accurate? That is what you said?
- 14 | A. Yes.
- 15 | Q. The Court, "Congratulations".
- 16 | A. Yeah.
- Q. Now, you've indicated you took issue with how she said "congratulations"?
- 19 | A. Yes.
- 20 | Q. And what was your issue?
- A. I just thought she -- I mean, it's kind of funny the way she said it to me, like she was out for me already or something, you know?
- Q. Line 13, Grand Juror, "I don't think I should be on this jury".
- 24 | A. Yeah.
- Q. Is that what you said?



- 1 A. Yes, because I was -- I said, "Because I'm the Town Judge".
- 2 | Q. And that's why you didn't think you should be on the grand jury?
- 3 | A. Yes.
- 4 Q. The Court responds, "You know, Judges are not exempt anymore".
- 5 A. Yeah, I remember that, her saying that.
- 6 Q. Grand Juror, "I know". Is that accurate?
- 7 | A. Yes.
- 8 Q. So did you know that Judges are not exempt from grand jury?
- 9 A. Nobody is now, they said.
- 10 Q. Then why would you get up there --
- 11 | A. Yeah.
- 12 | Q. -- and announce that you were a Judge?
- A. I know that -- like I said, a lot of people said that they're not going to pick
- 14 you because you're a Judge, and that's why I kind of said that.
- 15 Q. Do you consult with a lot of people when you preside over your cases?
- 16 A. No, no, I don't say nothing.
- 17 | Q. Then why would you consult with a lot of --
- 18 | A. Yeah.
- 19 Q. -- people as to whether you had an --
- 20 A. Well, I have a lot of friends who are --
- 21 Q. Let me finish.
- 22 | A. Yep, okay.
- 23 | Q. Why would you --
- 24 | A. Yeah.
- Q. Why would you consult with a lot of people as to why you had --



1	whether
2	A. Yeah.
3	Q or not you had an obligation to participate in grand jury empanelment?
4	A. Because I'm friends with a lot of the Sheriffs and Troopers, and one of
5	them like, one of the Sheriffs said, "Oh, they're not going to pick you.
6	You're a Judge," you know?
7	Q. Do Sheriffs have law degrees?
8	A. I don't know.
9	Q. The Court, "I had to show up for jury duty last year; so can you. You
10	know, it is going to be a presentation from the Attorney General's Office.
11	I don't you know, I don't think there will be conflicts". Is that your
12	recollection of what the Judge said at that point?
13	A. Yes.
14	Q. Response: "I have court on a lot of those same nights".
15	A. Yeah.
16	Q. Is that what you said?
17	A. Yes.
18	Q. Now, you've just testified that you were told the grand jury duration was
19	going to be six weeks
20	A. Yes.
21	Q correct?
22	A. Yes. I believe that's what they said, six weeks.
23	Q. So given that there are two Tuesday night court sessions a month, what's
24	the math on how
25	A. Yeah.
1	

(11	ton. Richara 1. Shyaer)
1	Q many days required court nights were going to be affected by grand
2	jury?
3	A. There's, like, two court nights, and then we're there every Tuesday night
4	anyways doing stuff.
5	Q. So two court nights would
6	A. Yeah.
7	Q be affected?
8	A. Yeah.
9	Q. Did you think that was a valid excuse for asking to be excused from
10	grand jury?
11	A. No, not really, but my main reason was my grandkids. I have him. Like
12	I said, it's hardship, and my daughter's
13	Q. So were you telling the truth when you told the Judge "I have court on a
14	lot of those same nights"?
15	A. Yes. Just the second and fourth night, and the rest, Tuesday nights, we're
16	there doing paperwork, getting cases set up for the next court night.
17	Q. If it's only if grand jury was only going to affect two court nights
18	A. Yeah.
19	Q that you were required or scheduled to appear, potentially
20	A. Yeah.
21	Q then how is it accurate to say "I have court on a lot of those same
22	nights"? Is that a lot?
23	A. No.
24	Q. So is this true or not?

A. Well, I guess it -- yeah, I'd say yes. I guess I said it wrong.

1	Q. What do you mean by that?
2	A. I don't know. I was so worked up and nervous, I don't even remember
3	what I was saying, tell you the truth.
4	Q. Do you understand what a grand jury does?
5	A. Not really. I think they explained that the grand jury is to see if they got
6	enough proof to find out for trial or
7	Q. I'm going to go back to the transcript. Line 25, page two, The Court,
8	"Okay. You will be done they will be done by"
9	A. Yeah.
0	Q "4:30?" Response from Assistant Attorney General McElwee let me
1	get the first name Andrew McElwee: "Right", indicating, "right, court
2	would be done by 4:30". Grand Juror response: "I have to get set up by
3	five o'clock, and I live in Petersburgh. I know everybody come in front
4	of me. I know they are guilty. They would not be in front of me". Was
5	that your response?
6	A. Yes, but I didn't mean it that way. I meant that, reason why people got
17	tickets is because they did something wrong. But I know people's not
8	guilty. They're innocent until proven guilty.
9	Q. The reason why did you just say "the reason why people get tickets is
20	because they did something wrong"?
21	A. Yeah.
22	Q. Can you explain that?
23	A. Well, like, speeding or maybe they broke into somebody's house or
24	committed a crime. That's the reason why they got a ticket to appear in
25	court because they did something wrong. But like I said. I know they're

1	not guilty. They're innocent till proven guilty, but.
2	Q. So in your mind, a ticket means that they did something wrong?
3	A. Yes.
4	Q. Whether it be and you're saying that a ticket, whether it's a ticket for

8	Q. That means in your mind that the Defendant before you did something
9	wrong?

11	Q. Do you see any issue with that thinking in sitting as Town Justice?
12	A. No. Like I said, they come in front of me, and "Do you plead guilty or
13	not guilty?" Most of the time like, plea deals with the ADA and Public
14	Defenders where they do the plea deals in all my times I been on the
15	bench, I hadn't ever changed a plea deal from a not guilty to a guilty.
16	Q. I'm going to give you a hypothetical. If someone's standing before you
17	and they have been charged with burglary in the third degree you know
18	what? Let's make it criminal possession of stolen property in the fourth
19	degree, a misdemeanor
20	A. Yeah.
21	Q okay, misdemeanor possession of stolen property, have they done
22	something wrong to get that ticket?
23	A. Probably, but not they've got to have proof that they did it, you know.
24	Rules we work with, the ADA and the Public Defender and they tell us,
25	what you know, how the ticket you know, how you got to write the

1	ticket and I mean, the plea deals and all that.
2	Q. Okay. Back to the transcript. What I just read, "I have to get set up by
3	5:00 p.m., and I live in Petersburgh", is that line accurate? Did
4	A. Yes.
5	Q you say that?
6	A. Yes.
7	Q. "I know everybody come in front of me. I know they are guilty". Did
8	you say that?
9	A. I don't remember saying that, tell you the truth.
10	Q. Are you disputing the accuracy of
11	A. Yes.
12	Q the transcript?
13	A. That's not how I was going to take it. I know they're guilty because they
14	did something wrong. That's how they got a ticket.
15	Q. Did you say this or not?
16	A. I don't remember saying that, tell you the truth.
17	Q. Are you disputing the accuracy of the transcript?
18	A. Yes, yes.
19	Q. Are you disputing Judge Laura Jordan's observations of when you came
20	before her during the empanelment?
21	A. Yes.
22	Q. Are you aware that there were other people present
23	A. Yes, there was people staying right in front of me and you know, looking
24	right at me when I'm trying to talk, and I was a nervous wreck and you
25	know.

1	Q. Okay. If you didn't say that, what exactly did you say?
2	A. I don't remember. It was a while back in October. Been so long. Tell
3	you the truth, I don't remember what I said. I didn't even know that guy
4	was doing the transcripts they were taking, you know.
5	Q. You didn't know what? I'm sorry.
6	A. I didn't know this guy was taking all that stuff on the recorder.
7	Q. You did not know are you saying that you did not know that the matter

11	get set up by 5:00 p.m
12	A. Yeah.
13	Q and living in Petersburgh, but you don't remember the next line. Did
14	you say, "I know everybody come in front of me"? Is that part true?
15	A. I don't remember that either, what I said.
16	Q. How about "they would not be in front of me"? "I know they are"
17	A. No.
18	Q "guilty. They would"
19	A. No.
20	Q "not be in front of me"?
21	A. That's all
22	Q. Don't
23	A I meant, that they were guilty because they did something wrong. But
24	they're not quilty till they come to court. They're innocent till proven

1 Q. Do you recall Assistant Attorney General McElwee saying "If you have a 2 particular night you need to leave early, I can let you out early"? 3 A. Yes, I remember him saying that. O. The Court then says, "I'm going to have you stay. There's a chance that 4 5 you won't be in the wheel and won't get chosen." A. Okay. 6 7 Q. "We'll work with your schedule to make sure you get to Petersburgh on 8 time for court. And again, this is Assistant Attorney General stuff, not 9 District Attorney stuff, so I don't think it is going to create any conflicts 10 for you. So I am just going to ask you to sit and wait". Do you recall the 11 Judge saying that? 12 A. Yes. That's how I kind of meant she said that "we're probably not going 13 to pick you anyways". 14 O. Did she say that though? A. Yes. She said, "We're not going to pick you anyways, but just sit down 15 16 and" -- and when I got picked, I went up there, and she asked again, and I 17 raised my hand, and I went over, and she said, "All right. You're 18 excused". 19 Q. Judge, show me in the transcript where she says "you're probably not 20 going to" --21 A. Well, I didn't see that --22 O. -- "get" --A. -- on there before, like I told you, but I remember her saying that, tell you 23 24 the truth. Honest to God, I swore I heared [sic] it. That's what she told 25 me.

1	Q. Okay. So you're saying it's not in the transcript?
2	A. No, I didn't see that.
3	Q. I'm on page four of five of the transcript. Court Clerk calls Juror Number
4	15, Richard Snyder. Court asks you to come up. Grand Juror, "I just
5	think I cannot do it because being a Judge and everything, I" what did
6	you did you say that, first of all?
7	A. Yes. That's when I wanted to say that I got my grandkids that I watch
8	every day, but I didn't get the chance to say that, because it's a hardship.
9	My daughter, you know, she works out of town. My son-in-law, he
10	works driving trucks, Connecticut. And something happens to my
11	grandkids, I'm responsible, something in school or one year that he
12	broke his leg, and I had to go down to school to get him. My family is
13	number one priority of me, my grandkids and my kids.
14	Q. If that were the case, then why didn't you tell the Judge that
15	A. Well, that's what
16	Q instead of introducing yourself as the Judge from Petersburgh?
17	A. That's what Dave Dellehunt told me, that I should have said that, but I
18	didn't think about that. The reason, I thought maybe, you know, being
19	the Judge, they wouldn't pick me. That's the reason why I said that.
20	Q. Line 12, The Court, "You don't think you can be impartial?" Grand

Like I told you, most of 21 ours is traffic tickets and evictions and small claims and --22 O. Have you ever been called for jury duty on another case? 23 A. Yes, I was excused because the person pled -- took a plea deal. 24 Q. When was that?

A. Probably eight years ago. That was in front of Debra Young.

1	Q. Any other times?
2	A. No. I think that's the only time. Debra Young, I know her. She's a good
3	friend of mine. She's a County Judge.
4	Q. Why are you telling me that?
5	A. Well, I'm just saying that she's a good friend of mine; that's all.

18	Q. Do you believe that individuals who come before you are guilty?
19	A. No. Like I said, they're innocent till proven guilty.
20	Q. But you think that they did something wrong?
21	A. Yes. That's why they got a ticket.
22	Q. Okay. So you don't see anything incompatible about what you told Judge
23	Jordan with how you conduct yourself in your court?
24	A. No, no.
25	Q. Was anything you said during grand jury selection a false statement under

4	was guilty when he or she appeared before you?


