### **City Court Judge in Jefferson County Resigns While Under Investigation**

Eric T. Swartz, a part-time Judge of the Watertown City Court, Jefferson County, has resigned while under investigation by the New York State Commission on Judicial Conduct.

In April 2024, the Commission apprised Judge Swartz that it was investigating a complaint alleging that he was suffering from a condition that interfered with his ability to perform his judicial duties.

Judge Swartz agreed to leave office on December 31, 2025, and never to seek or accept judicial office at any time in the future. The Commission accepted a stipulation to that effect signed by the judge and the Commission's Administrator.<sup>1</sup>

Judge Swartz waived the statutory provision of confidentiality applicable to Commission proceedings, to the limited extent that the stipulation and Commission's order accepting it would be public.

Judge Swartz has been a Judge of the Watertown City Court since 2021, having previously served as a Justice of the Watertown Town Court from 2020 to 2021. His current term would have expired on December 31, 2026.

### **Statistics Relating to Prior Commission Decisions**

The Commission has accepted 159 such permanent resignation stipulations since the procedure was instituted in 2003.

Since 1978, the Commission has also issued 290 determinations of admonition against judges in New York State, 358 determinations of censure and 185 determinations of removal.

### **Statement by Commission Administrator**

Commission Administrator Robert H. Tembeckjian made the following statement.

"While the Commission has authority to retire a judge for disability, Judge Swartz's agreement to leave the bench, in the face of a condition that interfered with his judicial duties, is commendable. We wish him well."
